

# Registration Form - Kaw River State Park Grand Opening Float

Join Friends of the Kaw (FOK) on September 4, 2010 for a float trip from Kaw River State Park Boat Ramp to the Kansas Ave. Bridge. Take 10:30am shuttle bus from upper parking lot to Kaw River State Park Boat Ramp (road closed from 7 to 10:30am for run/walk.) Float will launch after dedication of boat ramp and take out at the new access/portage park at the Topeka coffer dam for a BBQ lunch. After lunch and ribbon cutting, group will launch again and take out around 3:00pm under the Kansas Avenue Bridge. Shuttle buses will return participants to Kaw River State Park after refreshments at Overland Station.

## INSTRUCTIONS:

Bring snacks, lots of drinking water, hand cleaner, sunglasses, sun screen, hat, extra clothing, rain gear, plastic trash bag or dry bag and other appropriate gear. NO FLIP FLOPS or BARE FEET – wear shoes that can get wet and muddy! Please mail lower form (cut below) & your check made out to **Friends of the Kaw** postmarked by August 23, 2010.
